





The arrival of the COVID-19 pandemic brought about a heightened sense of uncertainty and confusion. Recognizing that every business in the Richmond region was facing unusual and unforeseen impacts, ChamberRVA provided guidance, support and resources to help navigate this challenging time.

Despite COVID-19 restrictions, our goal as a chamber was to continue to provide quality, informative programming for the public and our membership, albeit in a virtual format. Core annual events such as the Icons 2020, Mission Tomorrow, and the Education Summit, were online and successful thanks to the creative work of our staff, members and regional partners. We conducted over 15 Virtual Town Halls covering a wide range of topics throughout 2020.

During the early months of the pandemic, we highlighted vital information to over 500 virtual participants, covering information on PPP and EIDL loans, and CARES and SBA Loans. In the summer, we partnered with VCU and the Hispanic Chamber of Commerce to talk about staying safe at work. We heard recommendations from our Regional Health Directors about state and national trends, and how we in the business community could do our part to help contain the virus. Other webinars included topics on mental health, talent acquisition and retention during and after COVID-19 and helping small businesses "Get Back to Work."

While we were saddened to postpone the in-person events that bring our membership together, we are incredibly grateful for the technology and partnerships that allowed us to quickly shift gears and continue to provide meaningful programming to the public and business community. As we start 2021 we will continue to explore and create virtual programs that help to move the region forward and continue to provide the ChamberRVA as a valuable resource for your businesses.



Women Owned 58% Thousands of businesses across the region were deeply impacted by the economic effects of COVID-19. As part of our dedication to building a thriving regional community, in partnership with Facebook (Round One) ChamberRVA created the RVA Small Business Relief Fund, a program to provide immediate grants to qualified small businesses in the region. The Relief Fund provided \$2,500 in financial assistance to 100 small businesses in the form of an unrestricted grant to support rent, employee salaries, and operating costs as a stop-gap measure pending the release and distribution of federal and state aid.

We Care RVA Rebuild Project

In an effort to continue supporting the small business community after the initial round of the Relief Fund, ChamberRVA joined the Metropolitan Business League along with community and business partners in the We Care RVA Rebuild Project that provided emergency funding, crisis tools/resources and business coaching for small, women and minority-owned businesses impacted by the COVID 19 pandemic and the social justice demonstrations.



In May 2020, ChamberRVA partnered with Richmond region business, community and governmental leaders to form ForwardRVA, a coalition focused on creating an innovative reopening and planning framework.

The immediate focus was to support small, local businesses in reopening and operating safely by sharing tools and resources, including free Personal Protection Equipment, "We're Open" signage and important safety information.



With over 2,000 ForwardRVA reopening toolkits distributed to businesses and organizations from New Kent to Powhatan, Hanover to Hopewell, and all communities in between, RVA remained poised for a continued safe reopening period.

ForwardRVA is committed to continue to work together, encouraging region-wide conversations and actions ensuring we build the community we envision for the future.

Diversity, Equity & Inclusion Task Force

In response to the murder of George Floyd and the social unrest that followed both nationally and locally, we assembled a diverse task force of both ChamberRVA Board members and non-Chamber members, led by co-chairs Jennifer Hunter and Ed Baine.

This is an unprecedented opportunity to come together and unite our community with intentional engagement, adopt a new purpose, and position Richmond for a recovery that is more inclusive and therefore stronger. We're prepared to take bold action to establish our region as an inclusive and equitable community with diverse talent. ChamberRVA is at the beginning of a new journey – as are many of our members. We will broaden our reach, build new partnerships, and fully support our membership with tangible solutions as they undertake their own journeys.







ChamberRVA acts as a fierce advocate for businesses on issues that enrich a thriving and diverse business climate. We listen carefully to members and turn their input into action through proactive advocacy.

The 2020 legislative priorities focused on four guiding principles



Workforce Development & Education

Support education and training programs that develop a workforce possessing the skills and business-recognized credentials aligned with industry's current and future business needs.



Early Childhood Investment

Support investment in early childhood programs that enhance the opportunity for children to realize the benefits of their future education and become workforce ready.



Economic Development

Support aggressive, well-funded economic development to ensure that Virginia maintains a favorable business climate and policies that create jobs and encourage business opportunities and investment.



Healthcare

Support policies to minimize rising healthcare costs and to help businesses provide affordable coverage.

Successes

- Central Virginia Transportation Authority established with revenue stream providing estimated \$180+ million per year for regional and local transportation projects and transit
- Virginia's right to work law repeal defeated
- Oversight of early childhood initiatives transferred to Department of Education
- Various police reform initiatives adopted, including community care teams (Marcus alert), duty to intervene with officer misconduct, training in de-escalation techniques, and limitations on neck restraints and no-knock warrants

ChamberRVA Candidate Forums

ChamberRVA has hosted candidate forums throughout the Richmond region for every election cycle for over a decade. These events give candidates the opportunity to speak publicly in their localities in an open, unbiased setting.


Our country and region were experiencing challenging times – with a global pandemic, a turbulent economy and social justice unrest – making it even more important to learn a candidate's positions on policies and relevant issues. Preceding the November 2020 election, ChamberRVA partnered with Channel 12 and VPM to televise forums for Richmond mayoral candidates, as well as the 4th and 7th congressional district races.

ChamberRVA hosted the Virtual Education Forum, a series of five webinars featuring education, business and community leaders who spoke to the importance of equity in the education system, and best practices for helping students develop essential life skills.

The Virtual Education Forum recognized the collective efforts required to create equitable practices for students to succeed and focused on answering three questions

- 1 What is equity in education?
- 2 Why does it matter?
- 3 How do we achieve it?

The forum brought together over 500 participants for the opportunity to listen and share their perspective, while creating dialogue on how to move forward ensuring every child has equal opportunity for success.



Mission Tomorrow: Next Generation, in partnership with Junior Achievement of Central VA, looked a little different due to COVID-19 but the goal was the same: expose the region's 8th graders to a wide variety of careers in a fun, interactive way.

The region's vitality depends on its future workforce. Mission Tomorrow featured over 70 businesses that represented and shared the unique industry traits and skills required for tomorrow's workforce. This fun event introduced over 6,000 next-generation students to a variety of career opportunities available in our region with interactive engagement.

2020 was RVA NOW's startup year, with marketing campaign and programming launching in Q4.



ChamberRVA has long been dedicated to the attraction, retention and development of talent in the Richmond region. The RVA NOW program (formerly CampusRVA) was conceived to build a connection between area employers and recent college graduates, growing a skilled and diverse workforce in the Richmond region.

RVA NOW leverages ChamberRVA's strong reputation and business relationships to showcase the depth and diversity of employment opportunities to college students statewide. Not only does the region have powerhouse companies, it also offers a vibrant community in which to live, work, play and make an impact.

RVA NOW's Mission:

- Promote RVA as a welcoming, vibrant, and accessible place for young professionals and college graduates to make an impact
- Develop an employment marketplace
- >> Help students move and assimilate into the Richmond region
- >> Develop a plan of action to close workforce gaps

RVA NOW is supported by a GO Virginia grant, with matching contributions from private sector investors (through the Chamber's FutureRVA campaign), Richmond City, and the surrounding counties and guided by four stakeholder groups-Higher Education, Corporate, Student, and Community.

Since 2007, HYPE (Helping Young Professionals Engage) has worked to develop talent and strengthen the YP culture in RVA through events and programming designed to help empower and ignite the passions of Richmond's future decision makers.

HYPE's 2020 programming went virtual and allowed for all young professionals to attend free of charge as an act of good will in the midst of the pandemic. There were 15 virtual events held, focusing on relevant current topics including career resilience, self-care, emotional intelligence, equity and inclusion in the workplace and supporting local businesses.

Icons 2020

2020 was a year unlike any other, which called for an event unlike any other. Icons 2020 honored and recognized the young professionals in our community who have excelled in 2020 and made the most of a challenging climate. Whether in their workplace, in the small business that they own, or in the larger community, Icons showcased the brilliant and creative people who have pivoted their business models, led through crisis, or stood up against injustices across our nation.

Praised as "the best virtual event ever attended," Icons 2020 was hosted by radio celebrities Jack and Melissa from 103.7, welcomed over 175 attendees, and featured keynote speaker Rodney Robinson, 2019's National Teacher of the Year.

ChamberWomen is a platform for professional women to connect, educate and inspire, through leadership development, topical education and advocacy on key regional issues.

As the world adjusted to COVID-19, ChamberWomen pivoted, offering the majority of our programming free and open to the public, allowing for broader engagement and more exposure for our network.

Leading and Learning

Leading and Learning was a four-part series featuring a wide array of community leaders sharing their personal and professional experiences of leading during an unprecedented time. Speakers included Michelle Braden, President and CEO of MSB Coach; Senator Jennifer McClellan, Virginia District 10; Sherrie Armstrong, President and CEO of The Community Foundation; and Renee Haltom, Vice President and Regional Executive at the Federal Reserve Bank of Richmond.

Virtual Town Hall

Over 120 people attended a virtual town hall, hosted by Chamber Women, featuring Representative Abigail Spanberger who highlighted the COVID-19 congressional efforts and how the virus affected the region.

RVA Women Rising & Responding

ChamberWomen and HYPE hosted a panel of women who responded to the unique challenges and opportunities the Richmond region is facing. The event — RVA Women Rising & Responding — featured the founders of the Jackson Ward Collective, the co-founder of the Collaboratory of Virginia, and the founder and CEO of Glean LLC.



Moving Forward:

- We have started a ChamberWomen task force.
 The task force, comprised of both ChamberWomen members and non-members, will drive strategic planning for 2021.
- Based on current subscriptions sold, the ChamberWomen network will reach its highest membership to date in 2021.



Mentor Richmond is a way for early-career professionals to build relationships with each other while learning from some of our region's most dynamic leaders.

This unique team-based mentoring program has graduated over 300 emerging leaders since its inception in 2008. To provide for more opportunity for participation, lower costs, and streamline that agenda for participants, Mentor Richmond 2020 was held in two sessions and featured new program elements.

- >> Implemented Gallup Strengths and designed curriculum to incorporate identified strengths
- Most racially diverse session ever - 46% increase in diversity from Classes 22 and 23 to Classes 24 and 25
- Created a Slack Channel to encourage authentic conversation and collaboration throughout program
- >> Implemented homework and pairing assignments to match the virtual environment

At the heart of great leadership is the ability to ignite the extraordinary potential that resides within us. Leadership Lab is designed to create individual development and relationship building for emerging leaders who are interested in increasing their capacity to influence and lead within their organizations.

The 2020 Leadership Lab adjusted to a virtual format due to the challenges presented by COVID-19 restrictions, engaging 52 participants from 24 different organizations.

In December, ChamberRVA partnered with the Frontier Project to offer a three-part learning series – Ready + Resilient. This year-end learning series was designed to help equip participants by offering tangible tools to help them navigate 2021. The learning series had 45 people participate and engagement throughout the program was a success.

In 2017, ChamberRVA took steps to implement a new forward-looking initiative called FutureRVA. Our goals were to lay the groundwork for developing a more robust talent pipeline, enhance our ability to attract talent, foster regional sustainability, and improve our region's quality of life. The inaugural three-year plan concluded in June 2020, and it is clear there is still much work to be done.

We are asking our current FutureRVA investors to extend their commitments for one additional year as we build a strategic campaign to respond to our current environment and its impact on the longer-term trajectory of the overall work of the Chamber and region. We have an unprecedented level of collaboration within our community now, and we want to build on our current successes.


